Booth space for Venders is \$40.00 (2 SPACES FOR \$75.00), after Sept. 21nd one space \$55.00 two for \$95.00

Food Booth located between 12th & 13th Streets SET UP NEXT TO CURBS Venders \$100.00, after Sept. 21nd \$120.00

HEALTH PERMIT REQUIRED!

*Vehicles must be off Main St. by 8:30am vehicles should park in designated parking areas (see map on back)

Set up: 7am to 8:30am * Show hours: 9am to 5pm Breakdown times: 5:10pm to 7pm

Spaces will be assigned on a "first come, first serve" basis, so REGISTER EARLY!

No vehicles on Main St. between 8:30 a.m. & 5:10 p.m.

All vender vehicles must park in designated areas (marked by X on map) after unloading booth and merchandise (NO PARKING ON SIDE STREETS OR IN ALLEYS) violators will be towed at their own expense, see map on back side. All applicable Fortuna Vehicle & Municipal codes violations will be addressed by the Fortuna Police Dept.
